Conditions of Entry

1. My vessel is adequately insured and has a minimum Third Party Liability of £3,000,000.
2. My vessel is seaworthy, suitable to undertake an offshore passage and carries appropriate and adequate safety equipment for the number of persons on board.
3. I understand that, on the day of the event, the ability of the vessel's crew shall reflect the prevailing weather conditions.
4. My vessel has a keel, a working engine and can be reefed.
5. My vessel has a working VHF radio and is capable of monitoring Channel 72/77 throughout the event.
6. I accept that the Pursuit will be sailed under 'Colregs' and any additional specific sailing instructions issued by the Organisers for the event.

Legal Liability (to be signed by the vessel Owner/Skipper)

1. By completing and paying for an entry for the Nab Tower Pursuit 2019, I/we agree that I/we accept the **Conditions of Entry** and further accept that I/we are responsible for ourselves, our crew and our vessel, whether ashore or afloat.
2. No action or omission by The Organisers: i.e. The Organisers, their Management Team, Patrol Craft and anyone helping to run the Event, will relieve me/us, as participants, of my/our responsibilities.
3. By putting to sea, I/we imply the suitability of my/our vessel and the competence of the skipper and crew for the expected or forecast conditions. **My/our safety and that of my/our crew is my/our responsibility, including the decision to sail in the conditions on the day.**
4. I/we understand The Event Organisers shall not be liable for any loss, damage, death or personal injury howsoever caused to the owner/entrant, the skipper or crew, or vessel as a result of my/our taking part in the Nab Tower Pursuit. Moreover I/we, as owner/skipper, warrant the suitability of the entered vessel for the event.
